This consent is granted on the basis of examination of the information furnished by you in consent application(s) and the documents submitted therewith, subject to the following conditions:-

- 1 That this Consent to Establish is valid for a period from **08/09/2014** to **31/08/2017** or **date of Commencement of production / commissioning of the project or activities whichever is earlier .**
- 2 That this Consent is granted for manufacturing / producing following products / by products or carrying out the following activities or operation/processes or providing following services with capacities given below.

- 7 That the **Bulk Drug plant** will comply with the standards as prescribed vide MOEF notification No. GSR 826(E) dated 16th November, 2009 with respect to National Ambient Air Quality Standards.
- 8 That this consent to establish is being issued for modification/expansion of the plant for manufacturing of Glyoxalic acid 50%, Imidazole & IT derivatives, Tinidazole, Metronidazole, Metronidazole Benzoate, Ornidazole and Ofloxacin @ 7.50 TPD and manufacturing of by-products namely Ammonium Sulphate Solution @ 47 TPD.
- 9 That the project cost shall not exceed Rs. 75 Lacs.
- 10 That all conditions of Environment Clearance as imposed by SEIAA, Rajasthan vide letter no. F1(4)/SEIAA/SEAC-Raj/Sectt/Project/Cat 5Fb2(119)14-15 dated 31/07/2014 shall be complied with.
- 11 That no discharge of trade effluent shall be made within or outside the premises as per the proposals submitted to the Board.
- 12 That total water consumption shall not exceed 124 KLD and ground water shall not be extracted without prior permission of the Central Ground Water Authority(CGWA).

- 13** That, not withstanding anything provided hereinabove, the State Board shall have power and reserves its right, as contained **under section 27(2) of the Water Act and under section 21(6) of the Air Act** to review anyone or all the conditions imposed here in above and to make such variation as it deemed fit for the purpose of compliance of the **Water Act and Air Act**.
- 14** That the grant of this **Consent to Establish** is issued from the environmental angle only, and does not absolve the project proponent from the other statutory obligations prescribed under any other law or any other instrument in force. The sole and complete responsibility, to comply with the conditions laid down in all other laws for the time-being in force, rests with the industry/ unit/ project proponent.
- 15** That the grant of this **Consent to Establish** shall not, in any way, adversely affect or jeopardize the legal proceedings, if any, instituted in the past or that could be instituted against you by the State Board for violation of the provisions of the Act or the Rules made thereunder.

This **Consent to Establish** shall also be subject, beside the aforesaid specific conditions, to the general conditions given in the enclosed Annexure. The project proponent will comply with the provisions of the **Water Act and Air Act** and to such other conditions as may, from time to time, be specified by the State Board under the provisions of the aforesaid Act(s). Please note that, non compliance of any of the above stated conditions would tantamount to revocation of **Consent to Establish** and project proponent / occupier shall be liable for legal action under the the relevant provisions of the said Act(s).
